What Is Fentanyl

- Many drugs (even opioids) are made from naturally occurring plant compounds like opium which comes from the poppy plant.
- Other opioids that are now in our community are "synthetic" meaning they are human made in a laboratory. Most of the laboratories that make this deadly fake drug are overseas mainly China and Mexico.



Fentanyl – Why Should I Care?

- Fentanyl is 50 to 100 times more potent than morphine
- Synthetic opioids can be 99% cheaper per dose to produce than heroin
- Made in poor quality labs in China and Mexico
- Easy to get in any community now
- Dealers add fentanyl (up to 100 x stronger) to heroin and counterfeit tablets made to look like genuine prescription medications

Fentanyl Side Effects

- Drowsiness
- Confusion
- Trouble concentrating
- Tightness in the throat
- Stiff or rigid muscles
- Relaxation and euphoria
- Constricted pupils
- Physical weakness
- Itching



- Depressed breathing,
- Shallow/irregular breaths
- Sweating
- Constipation
- Dry mouth nausea
- Kidney damage
- Nightmares
- Abnormal heart rhythm
- Eczema & other skin disorders
- Reduced urine output



Signs Of a Fentanyl Overdose


- Small, constricted "pinpoint" pupils
- Falling asleep or losing consciousness
- Slow, weak, or no breathing
- Choking or gurgling sounds
- Limp body
- Cold and or/clammy skin/Discolored skin

What Is A Good Samaritan Law?



You Cannot Be Prosecuted for Helping With An Overdose

The Good Samaritan Law protects people assisting in an emergency overdose situation from arrest, as well as prosecution, for certain crimes.

You or the person overdosing cannot be arrested or prosecuted for:

- Possessing or using a controlled dangerous substance
- Possessing or using drug paraphernalia



You Can Call 911!





Such a tiny speck of fentanyl can kill you in under 2 minutes

- Fentanyl releases chemicals to brain stem
- Brain stem signals lungs to stop breathing
- 3. Dead on arrival

2 milligrams or 3 grains of salt









Recap!

Save A Life! (your own and others)

- Do not leave drinks unsupervised (e.g. going to the restroom at a party)
- Fentanyl can be disguised as something else
- Most people don't know they're taking it
- Items can be laced with fentanyl
- If you're somewhere and someone offers you a pill or anything remember the pencil point - just a speck can kill you

 if you or the person overdosing had drugs with you?
